We hope that you'll join us for the annual meeting, which will take place at Wellington High School. We thank you in advance for getting involved because your participation means so much to us.

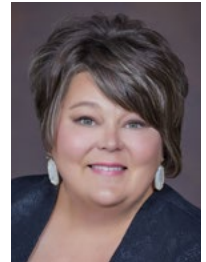
During the annual meeting we will share a few brief business updates, board election results and cooperative updates. But we are going to have a lot of fun too! We'll have activities for the

SCHOLARSHIP OPPORTUNITY

Sumner-Cowley Electric Cooperative will award academic scholarships to high school seniors pursuing a post-secondary degree or certification program in the fall of 2024. ELIGIBILITY REQUIREMENTS

Each applicant must meet the following requirements to be eligible for scholarships under this program.

- ▶ The applicant's parents or legal guardian must be a member of Sumner-Cowley Electric Cooperative receiving electric service.
- ▶ Applicants must meet the academic and any other requirements for entrance into the accredited school of their choice.

NOTE: A family member (as defined by SCEC's Bylaws and Policies is a person who, by blood or in-law, including half, foster, step and adoptive kin is either a spouse, child, grandchild, parent, grandparent, brother, sister, aunt, uncle, nephew or niece) of SCEC Board of Directors and employees are not eligible to participate in the scholarship competition.
