An Update on the February Weather Event and Your Bill

Almost a full year into the COVID-19 pandemic we were thrown another obstacle to navigate: Winter Storm Uri. This polar vortex caused historically low temperatures, stressing the electric generating capacity, natural gas supplies, and the ability of the transmission grid to move power across states and regions.

As a result of these challenges, the Southwest Power Pool (SPP) began asking us to do something unprecedented: conserve energy to avoid a total shutdown of our electric grid. As soon as your cooperative began asking for conservation of power, Sumner-Cowley Electric members rose to the task and lowered the total system consumption to just over 11 megawatts. As a reference, the system was using 18 megawatts before curtailment efforts were requested. Unfortunately, this was not enough, and

members served by our Bluff, Milan and Anson substations were twice called upon to endure mandatory outages. Sumner-Cowley Electric had no control over the circuits that were dropped, nor any control over the frequency and duration of the outages.

Sumner-Cowley Electric purchases your power through Kansas Electric Power Cooperative, Inc. (KEPCo). KEPCo was incorporated in 1975 as a not-for-profit generation and transmission cooperative (G&T). It is KEPCo's responsibility to procure an adequate and reliable power and energy supply for its 16 distribution electric cooperative members at a reasonable cost. KEPCo has a diverse portfolio that makes up the energy mix it purchases



on our behalf. This diversity provided somewhat of a shield for us as we were not so heavily reliant on electricity generated by natural gas.

That being said, KEPCo and, in turn, Sumner-Cowley Electric have been hit with significant costs associated with the February weather event. To exacerbate the situation, the exact amount will remain unknown until approximately September 2021 due to a Federal Energy Regulatory Commission (FERC) extension granted to the SPP to fully resolve the transactions and costs associated with Uri.

The power bill Sumner-Cowley received from KEPCo in early March for the February usage contained an additional \$126,000 related to our share of the event. This charge was passed through to the members of Sumner-Cowley through your Power Cost Adjustment (PCA). However, the total amount for Sumner-Cowley is currently known to be approximately \$406,500, leaving a balance of \$280,500. It is important to remember that this figure will likely change after the full settlement occurs later this year.

At the March 18, 2021 KEPCo Board of Trustees meeting, the board elected to defer and amortize the costs attributable to the weather event over a 24-month period. This decision helps mitigate the cost impacts to the nearly 300,000 rural Kansans served by the owners of KEPCo. It also demonstrates the value of four of the seven cooperative principles: Democratic Member Control, Autonomy and Independence, Cooperation Between Cooperatives, and Concern for Community.

The Sumner-Cowley Electric Board of Directors met at the cooperative on March 24, 2021, at 1 p.m. for their regular monthly board meeting. At this meeting, the directors elected to pass these monthly incremental charges through to the full membership of the cooperative over the next 24 months. At the current remaining balance owed, this will be approximately \$11,680 per month spread over all kWh sold in the month. An average residential member uses 1,200 kWh per month. This would add approximately \$2.40 to their billing for the next 24 months. A member using 3,400 kWh would be billed approximately \$6.80 also for the next 24 months. Please note that these approximations may change as more information becomes available.

Since the outset of this ordeal, Sumner-Cowley has been committed to achieving two goals: maintaining transparency and reducing the financial impact on our members. Sumner-Cowley's Board of Directors and management remain committed to these goals and will continue to work on your behalf until this situation has been fully resolved. Board of Directors Election Results

Sumner-Cowley Electric is a democratically controlled, not-for-profit electric co-op governed by seven directors elected by and from the members of their respective voting districts to serve a three-year term in office. In 2021, Districts 4, 6 and 7 were up for election. The incumbents were unopposed and deemed elected pursuant to a bylaw change approved by the membership at the annual meeting held in 2019.

District 4

KEITH LEDDY was originally elected to the board in 2012 and will enter his fourth term. He currently serves as board vice president. Leddy has obtained his Credentialed Cooperative Director certificate (CCD), Board Leadership Certificate (BLC) and through continued director training has



also earned his NRECA Director Gold Credential. He and his wife, Michelle, live in the rural Conway Springs area.

District 6

GABE SCHLICKAU has served one term on the board. He and his wife, Emily, reside near Danville, with their two children, Harry, 12, and Lena, 9. They are active in the local schools and youth sports activities. He is a long-time volunteer of the Harper County Fair Board and 4-H program. Schlickau is employed by CoBank,



where he works with agribusinesses throughout the state to meet their credit and banking needs. He is an advocate for agriculture, rural development, and the importance of the cooperative business model for our quality of life in southcentral Kansas.

District 7

JOHN SCHON was elected to the board in 2003 and will enter his seventh term. He currently serves as board president. He has earned his CCD and BLC certificates, and his NRECA Director Gold Credential through continued education. Schon and his wife, Tommie, live in the rural Argonia area.

How to Calculate Your 2020 Capital Credit Allocation

Sumner-Cowley Electric Cooperative has allocated 2020 margins to your individual capital credit accounts. Total margins for 2020 are \$991,728.97.

The chart on the right can be used to calculate the amount of capital credits that have been allocated to you based on your total patronage in 2020.

Your patronage is the total amount of Energy Charges, Power Cost Adjustments, Demand/Demand Minimum Charges, Horsepower Charges, Facility Charges, and Load Control Credits paid for the 2020 calendar year. Patronage does not include taxes, HomeGuard Lease or private Security Light charges.

To calculate your capital credit allocation, simply add up your total patronage for 2020 and multiply it by the allocation factor for the respective rate on your account. For example, a residential customer having \$2,000 in total patronage would receive an allocation of \$187.00 (\$2,000 x 0.0935021815).

Please note: If your rate changed at any point during the year, you will need to take the total patronage per rate and multiply it by each allocation factor.
